## KIYC Membership Fees and Entitlements

### Membership Drive Effective 2012

**The anniversary date for membership dues shall be the month of enrollment. All members shall provide a credit card to support their account. Payments submitted with the application will be returned if the application is not accepted.**

**FULL MEMBER** Annual Dues \$480. Initiation Fee is waived.

- Full use of the facilities, including pool and special events
- Right to vote
- Right to apply for a boat slip in the marina
- Eligible to serve as an Officer or Member of the Board of Governors at Large

#### **Annual Dues and Initiation Fee**

The dues for Full Members are reduced to \$480 and the Initiation Fee is waived. Full Members accepted under this 2012 Membership Drive will be required to spend \$50 per quarter at the Kent Island Yacht Club. This requirement shall begin with the first full calendar quarter following enrollment. Full members will be billed for any unspent balance each quarter. In addition, this required expenditure can not be used for Wave Makers apparel, Wave Makers events, Boat Slips or Dues.

**YOUNG ADULT MEMBER** Annual Dues = \$425. Initiation Fee is waived. No quarterly commitment.

Young Adult Membership is for new Members between the age of 21 and 35.

- Full use of the facilities, including pool and special events
- Right to vote
- Can not hold office
- Right to apply for a boat slip in the marina.

**SOCIAL MEMBER** Annual Dues = \$200. No Initiation Fee. No quarterly commitment.

- Unmarried spouse of a deceased voting member
- Full use of the facilities, including pool and special events
- No right to vote
- Can not hold office
- No right to apply for a boat slip

**GOLDEN MEMBER\*** Annual Dues = \$480. No Initiation Fee. No quarterly commitment.

Members 70 years of age or older who have been Full Members for a minimum of 10 years.

- Full use of the facilities, including pool and special events
- Right to vote and hold office
- Right to apply for a boat slip

**\*Note:** Any son, daughter, step-son, step-daughter, son-in-law, daughter-in-law, or ward, twenty-one (21) years of age and over, of any Voting Member of this Club who shall have been a Voting Member for at least one year, upon application and election in the same manner as a Full Member may become a Full Member of the Club without paying an initiation fee, provided that they comply with all other Sections of Article IX of the Bi-Laws

**NON-RESIDENT MEMBER\*** Annual Dues = \$335. No Initiation Fee. No quarterly commitment.

- Full use of the facilities, including pool and special events
- No right to vote
- Can not hold office
- No right to apply for a boat slip

**\*Note:** Members in good standing, who have been Members in good standing for a period of five years and whose permanent residence is more than 200 miles from the KIYC clubhouse may, at the discretion of the Board of Governors, apply for and be granted Non-Resident Membership. A Non-Resident Member is defined as a person who is a permanent resident of State other than Maryland, as evidenced by driver's license, voter registration, or other government issued documentation, and does not maintain any residence (house, boat, condo, RV, for instance) within 200 miles of the KIYC clubhouse.
